Chair Sanders introduced Ms. Barbara Hurst, Director of Business Affairs for the Association to present the Association financial report as of October 31, 2015. Ms. Hirsch said he was pleased to report that all of the Association financials are in good standing and there were no budget shortages, and they have received all of the student activity fees for the semester.

Chair Sanders requested a motion for the approval of Association Resolution 2015.A19. Trustee Morgo so moved and Trustee Pontieri seconded. Trustee Irizarry asked if the salaries were comparable to what the other College cafeteria works earned. Ms. Hurst replied they looked into what Aramark pays their cafeteria employees and they currently paying \$10/hour to non-student workers and student workers make \$9/hour. Further research of the surrounding area revealed that some companies pay \$11 to \$12 an hour, so they felt this was comparable to what was being paid in the area. Dr. McKay added the salary increase was necessary to be competitive with the employers on the east end. With no further remarks the motion was approved.

## RESOLUTION NO.2015.A19 - REQUESTING A WAGE INCREASE FOR THE TITLE "FOOD SERVICE WORKER" AT THE EASTERN CAMPUS

**WHEREAS,** in order to attract quality employees in the title of "Food Service Worker" at the Peconic Café at the Eastern Campus, it is recommended that the hourly wage rate be increased, and

**WHEREAS**, based on a survey of part-time salaries for cafeteria and delicatessen workers in Riverhead and Greenport, it is recommended that the hourly wage paid to the title of Food Service Worker be increased from \$8.94 to \$11.00, be it therefore

**RESOLVED,** that the hourly wage for the title of "Food Service Worker" be set at \$11.00 for the 2015-2016 academic year.
