Chair Sanders introduced Dr. Christopher Adams, Vice President for Student Affairs, to present the Association financial report for the period ending November 30, 2016. Dr. Adams said he was happy to report, the Association is doing very well in all of its accounts. The Association received a second disbursement from the College in student activity fees. In addition, the child care centers, received the SUNY Block Grants for the semester.

Dr. Adams said that at the January meeting he would present a proposal for approval concerning the speech and debate forensics team. Presently, the College has two teams one at the Michael J. Grant Campus and one at the Ammerman Campus. The coaches from the teams, the faculty advisors, have asked to combine the teams into one team College-wide team and open it also up to the Eastern Campus. Dr. Adams said that currently both the Ammerman and the Michael J. Grant Campus are spending a lot of money competing off campus and sometimes competing against each other. The request is at the recommendation of the Associate Deans of Student Services, coaches, and faculty advisors from the two campuses and would beneficial to the College. The full proposal will be presented at the January meeting.

## **RESOLUTION NO. 2016.A12** - Authorizing an Increase in the Hourly Wage Rate for Certain Part-Time Employees of the Suffolk Community College Association, Inc.

**WHEREAS**, in light of New York State's minimum wage increase to \$10/hour, effective 12/31/16, the College Association Advisory Committee has recommended to increase the hourly wage rate for the SCC Association titles of Student Worker, Peer Mentor and Usher, and

**WHEREAS**, the Vice President for Student Affairs supports these recommendations, and the President concurs, be it therefore

**RESOLVED**, that the hourly wage rate for the titles of Student Worker, Peer Mentor and Usher of the Suffolk Community College Association, Inc. shall be increased from \$9.18/hour to \$10/hour, effective 12/31/16.
