June 15, 2017

The meeting was held on Thursday, June 15, 2017 at 10:00 a.m. in the Media room of the Culinary Arts Center, in Riverhead, New York.

Vice Chair Morgo called for a motion to adjourn the Board of Trustees meeting and convene the Board of Directors meeting at 10:13 a.m. Student Trustee North so moved, Trustee Murray seconded, and the motion was approved unanimously.

Vice-Chair Morgo called for a motion to approve the Association minutes of the April 20, 2017 meeting. Student Trustee North so moved, seconded by Trustee Lilly the motion was approved unanimously.

Vice-Chair Morgo introduced Dr. Christopher Adams, Vice President for Student Affairs, to present the Association financial report for the period ending May 31, 2017. Dr. Adams said he was happy to report the Association was doing very well and trending positive in all of its accounts with three months to go in the fiscal year. He noted that the biggest distribution in May was for the commencement ceremony. He said it was an outstanding commencement ceremony, probably one of the College's better ones over the last couple of years.

Vice Chair Morgo noted that Dr. Adams had mentioned that the projections for a decrease in enrollment may have an impact going forward on the Association and asked him to share that information with all of the board members. Dr. Adams said there were four resolutions put forward this month. He noted the Association is microcosm of the College. It is a much smaller budget than the operating budget of the College and only has one stream of revenue coming in. All of the Association revenue comes from student activity fees. As our enrollment has levelled off over the last couple of years, there's been less student activity fees. When there are more part-time students coming in compared to full-time students, they are paying less of the student activity fee. Therefore there is less money coming in. Due to this he said the Association has had to tighten its belts. He said looking at the budget being presenting for the 2017-2018 year there is a 3.94% decrease in the money allocated across the three campuses, including College-wide athletics, the theatre program and the College-wide forensics, the two child care centers and the commencement ceremony budget. Dr. Adams added that if enrollment comes in a little higher, there will be more money that will be coming in by the student activity fees and then they will be able to allocate that money to the campuses.

Vice Chair Morgo said he asked Dr. Adams to explain the situation with the declining enrollment because it is something the Board has emphasized to Dr. McKay and his administrators, the recruitment of new students. Adding that Dr. McKay and his team have done an exemplary job. He recently saw one of the commercials, "I Started at Suffolk" and was very impressed. He asked if there has been any impact on projected enrollment from the Excelsior Scholarship initiative.

Dr. Adams said he would defer to Dr. Pedersen who had done some research on that for the College. Dr. Pedersen said in working with the Legal Affairs department they have looked into the policies that are still evolving for the program. Last year the College took in 10,628 new students, 5,931 of them were part time. The College has had a move toward part-time students from full-time students which they believe is due to the economy. Long Island is now at about four per cent unemployment which he says most economists feel is full employment for the Island. He added that the College's enrollment is counter to the economy. Historically, 17% of the Colleges full-time students would complete the requirements required of Excelsior on time. Looking at the 17% of full-time students, that would equate to 798 students who would be able to fulfill the requirements and half of those would not qualify because of family income being above the limit. The College therefore does not see a real change in enrollment due to the Excelsior program.

Trustee Canary commented it had been his fourth time attending the College's commencement ceremony. He was very impressed with the organization, the way it was conducted. He noted to sit on the stage and see the look in the graduate's eyes as they come on the stage is what it's all about. He thanked everybody involved with putting the commencement together and doing a super job. He noted the commencement speaker, Commander Robert "Hoot" Gibson, who is an alumni was very impressive and a great guy.

Student Trustee North agreed and said it was a great event the guest speaker was great, and being graduate himself and watching all the other students his fellow students graduate, was an honor.

Trustee Canary added that in addition to the commencement speaker, the student speeches from the three campuses were really amazing stories and amazing students.

Vice Chair Morgo called for a motion for the approval of Association Resolutions 2017.31 through 2017.46. Student Trustee North so moved, seconded by Trustee Murray, with all in favor the motion carried.

RESOLUTION NO. 2017. A2 - Accepting the Independent Auditor's Report of the Suffolk Community College Association, Inc. for the Fiscal Year Ending August 31, 2016

WHEREAS, the Vice President for Student Affairs supports these recommendations, and the President concurs, be it therefore

RESOLVED, that all Association full-time titles without a step increase are hereby granted a three percent (3%) increase for the 2017-2018 academic year.
