The first resolution is recommending Andrea Popalardo as that candidate. He noted her resume was sent to the Board via email. The second resolution is approving the appointment of a Manager of Dining Services and Catering for the Peconic Café. A full search was completed and they are recommending that Evangelos Kakaris be selected as the candidate for the position.
