<p><b>Federal Direct Loan</b></p> <p>Available for all summer sessions (5/28/13 – 8/1/13)</p> <p>The recommended deadline to submit the <i>Summer Aid Request Form</i> is 4/19/13 (to ensure loan is approved prior to first summer payment due date). <b><u>The deadline to request a summer Federal Direct Loan is 6/10/13.</u></b></p>	<p><i>Summer Aid Request Form</i></p> <p style="text-align: center;">AND</p> <p>» <b>2012-13 FAFSA</b></p> <p><b>Note:</b> If offered a Federal Direct Loan, first-time borrowers must complete mandatory loan entrance counseling and sign a Master Promissory Note at:</p> <p><b>www.studentloans.gov</b></p>	<ul style="list-style-type: none"> <li>• Must enroll for a minimum 6 credits (all sessions combined)</li> <li>• Available only if student enrolled in degree program fall 12/spring 13</li> <li>• Must have remaining loan eligibility (fall/spring and summer combined may not exceed annual loan limits)</li> <li>• Annual loan limits for 2012-13, including summer term:  <i>1<sup>st</sup> year (&lt; 32 cr.): \$5500</i>  <i>2<sup>nd</sup> year (32+ cr.): \$6500</i>            Independent students: up to \$4000 additional Unsubsidized Loan.</li> </ul>

<p><b>Federal Work-Study (FWS)</b> 5/20/13 – 8/25/13</p>	<p><i>Summer Aid Request Form</i></p> <p style="text-align: center;">AND</p> <p>» <b>2013-14 FAFSA</b></p>	<ul style="list-style-type: none"> <li>• Must be registered for fall 2013 courses</li> <li>• Must demonstrate financial need based on FAFSA results</li> </ul>
<p><b>TAP</b> (NYS Grant)</p>	<p>» <b>2013-14 FAFSA</b></p> <p style="text-align: center;">AND</p> <p><i>Express TAP Application (apply when filing FAFSA)</i></p>	<ul style="list-style-type: none"> <li>• For full- or part-time study (minimum 6 credits plus additional criteria)</li> <li>• NOT recommended if student plans to attend a four-year school or if unable to complete degree at SCCC within two years. <u><i>Discuss with Financial Aid before applying.</i></u></li> </ul>

## PAYMENT DEADLINES / DEFERMENT PROCEDURES:

To avoid de-scheduling, payment for summer courses is due on the following dates:

First Five-Week Session / Eight-Week Session  
Second Five-Week Session

May 14<sup>th</sup>  
June 17<sup>th</sup>

If financial aid is approved prior to above dates, you may request a deferral of payment from the Financial Aid Office. **IMPORTANT: We recommend that you apply for the above financial aid programs at least four weeks prior to your payment due date.**
