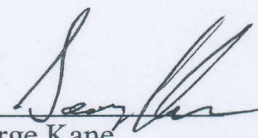

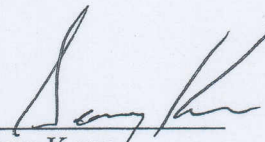

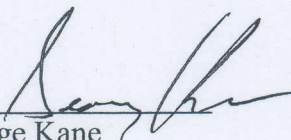

CHILDREN'S LEARNING CENTERS FOR 2010-2011**

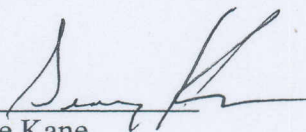
WHEREAS, the College Children's Learning Centers Advisory Committee has recommended an increase in the tuition fees, and

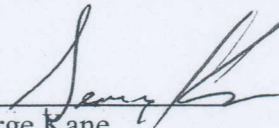
WHEREAS, the Associate Vice President for Student Affairs has approved these recommendations, and the President concurs, be it therefore

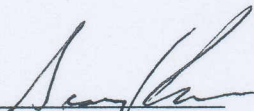
**RESOLUTION NO. 2010.A10 ACCEPTING THE INDEPENDENT AUDITOR'S

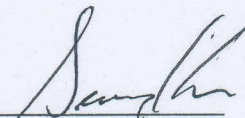

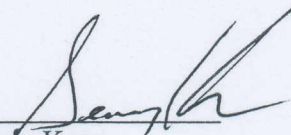
**RESOLUTION NO.2010.A13 APPROVING STUDENT ACCIDENT INSURANCE
