**RESOLUTION NO. 2024.75 – Approving a Plan of Dissolution and Distribution of Assets for the Center for Social Justice and Human Understanding, Inc.**

**WHEREAS**, The Suffolk Center on the Holocaust, Diversity, & Human Understanding, Inc. ("Center"), was incorporated as a Non-for-Profit type B corporation under Section 201 of the New York State Non-for-Profit Corporation Law ("NFP Law") on March 21, 2003, with Suffolk County Community College (the "College") as the sole member of the Corporation; and

**WHEREAS**, the Corporation was formed and has been operated for the purposes of promoting and enhancing a collection of artifacts and other memorabilia owned by the College relating to diversity and historical events such as the Holocaust, slavery and genocide; teaching diversity and tolerance at the College, in the community and to secondary school students; and raising funds in furtherance of these objectives; and

**WHEREAS**, on August 7, 2017, the Corporation filed a Certificate of Amendment with the Department of State, changing the Corporation's name to the "Center for Social Justice and Human Understanding, Inc.," and specifying that the Corporation is a charitable corporation as defined in Section 201 of the NFP Law; and

**WHEREAS**, upon evaluating the functions, operations and finances of the Corporation, it has been determined that a dissolution of the Corporation would be in the best interests of the Corporation and of the College; and

**WHEREAS**, in accordance with the "Dissolution Plan and Distribution of Assets" enclosed herein as Attachment I, the College will remain the owner of artifacts, books and memorabilia comprising the collection currently managed by the Corporation; the College will take over the management and control of the collection as well as of the Center's endeavors and activities; and the Corporation's financial assets will be distributed to the Suffolk County Community College Foundation (the "Foundation");

**WHEREAS**, the Center's Board of Directors unanimously approved the Dissolution Plan and Distribution of Assets;

**WHEREAS**, the Dissolution Plan and Distribution of Assets shall not become effective unless and until the Foundation shall adopt a resolution accepting the terms of the Dissolution Plan; and

**WHEREAS**, the composition of the advisory committee will be determined by the College President, and will include representatives from the current directors of the corporation, be it therefore

**RESOLVED**, that the College's Board of Trustees hereby approves the dissolution of the Center, and further approves the attached "Dissolution Plan and Distribution of Assets" for filing with the Attorney General of the State of New York.

ATTACHMENT 1

**PLAN OF DISSOLUTION AND DISTRIBUTION OF ASSETS**

Plan of Dissolution and Distribution of Assets of

The Center for Social Justice and Human Understanding, Inc.

The Board of Directors of The Center for Social Justice and Human Understanding, Inc. (the "Center" or the "corporation"), and Center's sole member, Suffolk County Community College, have considered the advisability of voluntarily dissolving the corporation and have determined that dissolution is in the best interest of the corporation.

1. (A.) The assets of the corporation and their fair market values are as follows:

- (1). M&T Bank, account balance as of 10/16/24: \$9,662.42
- (2). Bethpage Business, Savings Account balance as of 11/8/24: \$8,845.39
- (3). Suffolk Federal Credit Union Share Savings #1 balance as of 10/16/24: \$2,878.73

(B.) In addition, the following assets are held as donor restricted funds, as of 10/16/24:

Cooper Scholarship\* restricted funds total sum: \$68,602.01, invested as follows:

- Suffolk Federal Credit Union CD #14: \$13,766.99
- Suffolk Federal Credit Union CD #16: \$17,941.77
- Vanguard Investments: \$36,893.25

\*The Cooper Scholarship was created in honor of the late Ethel K. Cooper to provide financial awards to students engaged in projects which promote social change, or have demonstrating outstanding community services which reflects the altruistic spirit of Mrs. Cooper.

2. The corporation has no liabilities.
3. The organization proposed to receive the corporation's assets, Suffolk Community College Foundation, Inc., is a charitable organization engaged in activities substantially similar to the corporation's activities and consistent with any specific dissolution requirement specified in the corporation's Certificate of Incorporation. The Foundation shall segregate such funds and restrict their use to the mission of the Center.

For each organization proposed in this Plan to receive the assets, the following documents are attached as Exhibit 1:

- X the certificate of incorporation, with all amendments;
- X most recent financial report; and

X an affidavit from a director or officer stating the purposes of the organization, that it is currently exempt from taxation under Section 501 (c)(3) of the Internal Revenue Code, that it is up to date in its registration and annual financial filings with the Charities Bureau or is exempt from registration with the Charities Bureau, and if restricted assets are being transferred, a statement that those assets will be held in accordance with the restrictions.

4. (A.) In addition to Attorney General approval, the following governmental approvals of this Plan are required and copies of the approvals will be attached to the Verified Petition submitted to the Attorney General.

Approval of the Commissioner of Education and President of the University of the State of New York.

5. Within two hundred seventy (270) days after the date on which the Attorney General approves the Plan, the corporation shall carry it out. After the Plan is carried out, a Certificate of Dissolution shall be signed by an authorized director or officer and all required approvals shall be attached thereto.


