LETTER OF AGREEMENT

between

Long Island University

Brentwood Campus

and

Suffolk County Community College

SEAMLESS TRANSFER AGREEMENT

The purpose of this document is to provide a procedure for Suffolk County Community College students to attend Long Island University's Brentwood Campus under the special terms and conditions of this agreement known as the Seamless Transfer Agreement.

In recognition of the need for improved methods of associate degree transfer opportunities without loss of credit, time and tuition expense, this agreement is put forth in the hope that the model will be employed on a general basis between Suffolk County Community College and Long Island University.

Due to approved modifications in the LIU CWPost College of Management curriculum, SCC students majoring in Accounting, Criminal Justice, Management, Marketing, and Finance, may transfer without loss of credit by following the existing curriculum of SCC in areas listed above (SCC bulletin copy attached) providing SCC requires the following courses for each program area:

- A.S. Degree in: **Business** ✓ (Management, Marketing & Finance)
 Require Math 64 as Math Elective
 Require a Laboratory Science Course
 Require a Four Credit Liberal Arts & Science Elective.

- A.A.S. Degree in: **Criminal Justice** ✓
 Recommend English 11 and English 13

- A.S. Degree in: **Accounting** ✓
 Require Math 36 and Math 64
 Require Lab Science or Core Course
 Require one Four Credit Liberal Arts Elective or Lab Science
 Require either BD 57 or BA 51 as Business Elective
 Recommend Accounting 84 as Accounting Elective

All of the course designations are those of SCC as described in the current SCC Bulletin. Plans of Study are attached for each area specifying the exact course equivalents for the LIU CWPost curriculum which is in effect for the Brentwood Campus. SCC students opting for enrollment in the CWPost Campus will have the same Seamless Transfer Program for the same areas of study under the same terms and conditions.

LIU Brentwood agrees to provide academic advisement, admissions counseling, and financial aid information at any campus of SCC to students, faculty and staff interested in or concerned with these programs. Special financial aid programs for SCC students exist which may be applied for by contacting the Admissions and Financial Aid Office at (516) 273-5112. LIU Brentwood agrees, upon acceptance of the agreement, to prepare a descriptive brochure, at its expense, for distribution to SCC students. SCC shall provide appropriate space for LIU Brentwood representatives to discuss Seamless Transfer at all SCC campuses and access to appropriate staff and faculty for consultation on the availability of this agreement.

LIU and SCC agree to notify the President of the others' campus of any modification in curriculum or policy that would alter, in any way, the intent of this agreement. Additional programs may be added to the Seamless Transfer Agreement upon recommendation of the appropriate offices of both institutions.

This agreement shall commence 1 September 1993 and shall be automatically renewed on the first of September of each succeeding year unless modified by mutual consent, in writing, by all concerned.







**Articulation Agreement
between
Long Island University/C.W. Post Campus
and
Suffolk County Community College**


This articulation agreement confirms that Suffolk County Community College students completing the Associate in Arts degree in Liberal Arts and Sciences: Adolescence Education/Mathematics Emphasis will be able to transfer with junior status into the Bachelor of Science degree program in Adolescence Education - Mathematics at the C.W. Post Campus of Long Island University. Credits from the A.A. degree at Suffolk will transfer to C.W. Post and apply to the B.S. program according to the attached sheets.

Students who transfer directly to C.W. Post upon completion of the Suffolk County Community College A.A. in Liberal Arts and Sciences: Adolescence Education/Mathematics Emphasis are accepted into the B.S. Adolescence Education - Mathematics program and are awarded automatic transfer scholarships, the values of which are dependent upon the student's Suffolk County Community College cumulative grade point average.


Freshman students at Suffolk County Community College may enter C.W. Post as part of C.W. Post/Suffolk County Community College Joint Admissions Program. Joint Admission students receive specific C.W. Post campus privileges while attending Suffolk County Community College and, upon transfer, are awarded automatic Joint Admission Scholarships, with values varying according to the Suffolk County Community College cumulative grade point average.

This articulation agreement is effective beginning with the Fall 2006 semester. It will be reviewed each year and amended if changes occur in either school's programs. Suffolk County Community College will provide students presently in its programs with all information pertaining to this agreement, will list C.W. Post in any publication that refers to articulation agreements, and will allow C.W. Post to visit Suffolk County Community College at least once during each semester. The current transfer course equivalency table is attached.


We look forward to a fruitful period of cooperation in this positive endeavor to serve our students and institutions.








